'Leave No Deaf Child Behind'

Responding to the Inclusion Needs of Deaf Children in Low Resource Health and Complex Humanitarian Settings



Suheir Al Baderna

Director of Rehabilitation – Palestinian Red Crescent Society

Suheir Al Baderna was born and grew up in Palestine. She acquired a BA in English at Birzeit University, Ramallah, and then attended a one-year diploma as an introduction to Deaf education and sign language. This equipped Suheir with the basic skills required to be a teacher of the Deaf. Suheir then went on to attend many workshops and conferences in the field of rehabilitation.

She then started work in 1996 as a teacher for Deaf students in the total communication centre for the Deaf. In 2001, Suheir became the head of the centre and then, in 2010, became Head of the Rehabilitation Department at Palestine Red Crescent Society. This department is responsible for all the rehabilitation services provided for the persons with disabilities. The rehabilitation department runs schools for Deaf, centres for children with learning and special needs, centres and units for physiotherapy and occupational therapy, units for speech and audiology, in addition to community based rehabilitation programmes.



Rt Hon Lord Bruce of Bennachie

DeafKidz International - Special Representative

Sir Malcolm Bruce was the Liberal Democrat MP for Gordon from June 1983 until the election in May 2015 when he stood down from Parliament.

Prior to being an MP, Malcolm worked in marketing, economic development and journalism. He was the economic officer to the North East of Scotland Development Authority when oil was first discovered in the North Sea and went on to establish, with a partner, Aberdeen Petroleum Publishing in 1981.

Throughout this time, he has acquired a detailed knowledge of the oil and gas industry, and in particular, its relations with Government.

Malcolm was also Chair of the influential International Development Select Committee from 2005 – 2015. He led many inquiries into the work of the Department for International Development and has travelled widely in sub-Saharan Africa and South East Asia.

Malcolm was Deputy Leader of the Liberal Democrats Parliamentary Party from January 2014 – May 2015.

Prior to this he was Party spokesman on Trade and Industry, Environment, Food and Rural Affairs and Treasury. He has also been a member of the Scottish Affairs Select Committee, the Trade and Industry Select Committee, the Committee for Standards and Privileges and Treasury Select Committee.

Malcolm has been Scottish Affairs Spokesman and Leader of the Scottish Liberal Democrats (1988-92) and played a key role in shaping the devolution settlement through the Scottish Constitutional Convention.

As the father of a grown-up deaf daughter Malcolm has long campaigned on deafness issues in Parliament. Malcolm was the founding Chair of the All Party Parliamentary Group (APPG) on Deafness. He is also President of the Grampian Branch and a National Vice President of the National Deaf Children's Society and a Vice President of Action on Hearing Loss. In November 2014 he was honoured to receive the prestigious Joseph Maitland Robinson Award for Outstanding Contribution as part of the Signature Annual Awards.

He was made a Privy Councillor in 2006, was made a Knight Bachelor in the Queen's Birthday Honours in June 2012 and was made a life peer in the Dissolution Honours list in August 2015.



Joanna Clark
Director – Deaf Child Worldwide

Joanna began her career as a manager in the NHS. From there she moved to Pakistan to manage Save the Children's Primary Health Care Programme for Afghan Refugees following which she worked for five years in Vietnam as Save the Children UK's Country Director. Since then she has continued to work as a senior manager in international development in a wide range of roles and regions. For the last three years she has been the Director of Deaf Child Worldwide, the international arm of the National Deaf Children's Society.

Deaf Child Worldwide supports work with partners in South Asia, East Africa and Latin America that enables deaf children and young people to be fully included in family, education and community life.



John Coster
Founder – Documentary Media Centre

John works to demonstrate how documentary film, photography, audio & new media can be used to reveal our world - real people, real places, real events.

His Documentary Media Centre organises and delivers a range of events, workshops, talks, exhibitions along with a Reportage Club which hosts 'in conversation' sessions with media experts.

As organiser of the Leicester Docfilm Festival, he works to screen documentary film submissions from across the globe. John has worked as International Advisor to Film Goals NGO (Kenya) to establish a film festival and works with DeafKidz International as a media adviser.

His 'Conflict Reportage' - on the subject of conflicting reporting between 1914 and the present day – and his Museum of Citizens Media has met with critical acclaim. His 'In Conversation' sessions have seen John probe journalists, broadcaster and authors at the Frontline Club, the Imperial War Museum and the London Club of the Rifles.



Steve Crump

Founder – DeafKidz International / DeafKidz America

A global health professional, Steve has worked at senior level in a number of international development, relief and health organisations including ICRC, MAG and the Royal College of Paediatrics and Child Health. He is currently Head of International Affairs at the Royal College of Physicians.

Deafened himself, Steve originated and founded DeafKidz International when he learned of the appalling abuse endured by D/deaf children in Uganda. Resolving to do something, the result was DeafKidz International. Steve has recently returned from the US where he has established the 501 (c) 3, DeafKidz America; an awareness, business development and fundraising platform aimed at supporting the valuable work of DeafKidz International and its partners worldwide. DeafKidz America also leads on representation to USAID and the New York based, UNICEF.



Professor Rashid Gatrad OBE DL

Founder – Midland International Aid Trust

Professor Gatrad OBE is a consultant Paediatrician at the Manor Hospital in Walsall and also Professor of Paediatrics and Child Health at the Universities of Kentucky (USA) and Wolverhampton. He is Doctor of Medicine, and holds a PhD and a DSc. For services to children in the West Midlands he was awarded an OBE. For halving death rate in new born babies, and much more, he was awarded the Freedom of the Borough of Walsall. He has provided humanitarian aid to over 20 countries and has built a hospital in Gujarat where Cleft, breast, limb and cataract operations are carried out. The Queen recognised all this and his global charity work, as CEO of Midland International Aid Trust, by making him a Deputy Lieutenant to Her Lord Lieutenant in 2014.



Emma Gilbert

Leicestershire Police

Emma Gilbert is a Detective Sergeant, currently serving with Leicestershire Police, with extensive experience of response, community and criminal investigation policing. She is a specialist in child protection and the safeguarding of children and young people. In addition to these duties, Emma manages the UK's innovative Police Link Officers for Deaf people (PLOD) scheme. An integral member of the DeafKidz International team and a vigorous champion for the rights of D/deaf children, Emma is working to introduce the concept of PLOD to all UK Police forces and, in partnership with DeafKidz International, policing agencies in South Africa, Kenya, Zimbabwe and Jamaica.



Sanjiv Kumar

Consultant Otologist / ENT Surgeon - University Hospital of North Midlands

Sanjiv was appointed Consultant ENT Surgeon at UHNM in January 2014. He undertook fellowships in Otology and Cochlear implantation from Addenbrooke's' Hospital, Cambridge and a Neurotology and Lateral Skull base fellowship from University of British Columbia, Vancouver before taking up his current post. Sanjiv's subspecialty interests are middle ear surgeries, Bone Anchored Hearing Aid, balance disorders and inner ear pathologies. He also continues to have a general ENT practice, including paediatric ENT. Sanjiv's research interests are Middle Ear Mechanics, Meniere's disease and Eustachian tube dysfunction.

Cochlear Europe

Mariska Leighton is a Marketing Consultant working with Cochlear Europe. Originally from South Africa, Mariska has focused her last 10 years of her career on healthcare in the UK. Mariska will be presenting on the burden and risk of Chronic Suppurative Otitis Media (CSOM), more commonly known as discharging or runny ears. Kelvin is a Clinical Business Manager working for a global hearing implant company Cochlear who manufacture a range of devices to help with many different types of hearing losses. Before joining Cochlear Europe in 2014, he worked for the NHS at the Nottingham Auditory Implant Programme for 10 years in the Paediatric department as a Clinical Scientist. Royal Dutch Kentalis is a national provider of education and care for people with hearing and/or communication difficulties. He has been active in the field of Audiology and Deaf Education for 35 years. Fred started his career as an electronics engineer at the Institute for the Deaf in Sint Michielsgestel. Through his work at the Audiological Centre he got interested in the field of Audiology and was involved in several research projects, often related to Cochlear Implants and hearing tests. During this period he did the hearing aid dispensers course and he completed his Bachelor degree on Audiology at Fontys University. He also studied Educational Audiology at Mary Hare in Newbury. For the last 7 years he is coordinating training projects for Kentalis International, mainly in developing countries. Fred was also involved for over 10 years as a volunteer at Eardrop Foundation Netherlands where he chaired the Audiological Rehabilitation committee. Professor Andrew Smith
International Centre for Evidence in Disability

From 1996 to 2008, Andrew was responsible for the program for Prevention of Deafness and Hearing Impairment at the World Health Organization (WHO). Prior to working at the WHO, he was head of the Hearing Impairment Research Group at the Liverpool School of Tropical Medicine. He has also worked for the UK Medical Research Council in the Gambia, and for the UN High Commissioner for Refugees in Pakistan. Originally trained as a pediatrician in the United Kingdom and Canada, Andrew later developed an interest in international public health issues. He has been principal investigator and has provided technical advice in surveys and intervention studies on hearing impairment in developing countries around the globe. Today, he is an Honorary Professor at the London School of Hygiene and Tropical Medicine. His principal interest continues to be the epidemiology and prevention of deafness and hearing impairment in underdeveloped parts of the world.
